The site will be open to exhibitors from 13:00 on Friday  $29^{th}$  July. Exhibitors must vacate the site by 12:00 on Monday  $1^{st}$  August.

Vehicles on display must be parked in the area designated for it by the show management.

Exhibitor caravans and tents must be sited in and remain within the pitch designated by the show management in order to comply with fire safety regulations.

When taking part in displays, it is requested that participants make every effort to dress as a crew in appropriate Firefighting uniform to the age of the vehicles being used. This is to ensure visitors experience authentic re-enactment.

Vehicles must be driven at the 10mph site limit at all times. Vehicles may not be manoeuvred when the site is open to the public (10:00-22:00) without being permitted and escorted by show marshals.

When in the arena vehicles may use audible visual and warning devices. Any vehicles MUST be driven at a pace that is suitable to the conditions and shows the professional nature of emergency vehicle drivers. Excessive speed is not permitted and will result in the driver/vehicle taking no further part in the display(s)
